

## **Fueling the Future of Ministry**

The Foundation has been moving rapidly through the process of reorganizing the three former Foundation ministries, North, South, and Area, into one edge organization. While there have been many changes in the four short years since our creation, the leadership of the Foundation felt it was time to change the physical look of the Foundation to match the reality of what we were becoming. The Rejuvenate ministry provided the big story of 2014 for UMFI. The \$3,000,000 Lilly Endowment Inc. matching grant will be met because of dedicated supporters, congregations and a significant gift from Indiana University Health.

The Rejuvenate ministry was created with a matching grant from Lilly Endowment in 2008. Rejuvenate provides educational opportunities for clergy and laity in financial stewardship. It also has provided substantial financial support to clergy in the areas of education, retirement, financial emergencies or career transitions. 162 clergy and their families received financial support in 2014; 129 of these grants were matched by local congregations for retirement support. Since the inception of the original grant, Rejuvenate has distributed over \$4,412,000 in support of our clergy.

2015 will see the conclusion of the Lilly Endowment grant. UMFI has been studying how to incorporate the significant aspects of this ministry into the on-going structure of the Foundation. The education component has been identified by several groups as critical to the continued growth and financial well-being of our clergy, so the Foundation created a Financial Stewardship Education committee. This committee will work closely with both the Conference Director of Leadership Development and the Conference Generosity and Gratitude team in providing educational opportunities for both clergy and laity in financial stewardship. Additionally, a Clergy Outreach committee will be formed to continue the essential work of identifying and meeting the needs for all clergy.

Mary Ann Moman, the Director of Rejuvenate, will continue to meet with pastors in the Conference. She will also begin focusing on developing additional funding in two areas. The Foundation established a fund to address financial emergencies of our active clergy and is expanding the current resources available for seminary scholarships and educational debt.

The Foundation manages over \$65 million in assets of our churches, boards, agencies, endowments and trusts. We provide pools of assets at various risks and return levels. By pooling assets, we are able to provide a cost effective method for our churches to invest in the market. While some may think investing in the market is "risky business", to provide adequate growth in endowed funds, market investments are critical.

Our primary investment provider is the institutional investment division of the General Board of Pensions and Health Benefits, WesPath, named in recognition of Wesley's path. These funds are actively screened to be compatible with the social principles of The United Methodist Church. WesPath not only screens out specific stocks, they also actively work with companies to improve their response in a variety of areas. The Foundation does offer two non-screened public funds, which are monitored by the Foundation.

the Foundation would not be in ministry without the wonderful support of our donors. These donors support the Rejuvenate ministry, create endowed funds to fund ministry far into the future, and establish trusts and annuities to both provide an annual income for themselves and to fund future ministries. At December 31, 2014, the Foundation managed almost \$21 million in trusts, endowments,

designated funds, donor advised funds, charitable gift annuities and remainder trusts. The Foundation distributed over half a million dollars in grants from these funds supporting local churches, missions, seminary students, our retired clergy and many other ministry areas.



This year, the United Methodist Youth Home in Evansville was able to begin their "Guiding a Brighter Future" program with the funds received from a Foundation grant. This program has allowed the home to expand the counseling offered to their participants. Many participants have led difficult lives and need this support to be able to develop into healthy youth and adults who can feel and accept Christ's love.

The PB Smith Scholarship streamed into a new area with a scholarship to the pastor of Darlington UMC. Last year Bryan & Maureen Langdoc spent a semester in England while Maureen worked on her degree. Instead

of just finding a replacement preacher for those months, Bryan came up with an innovative approach to worship. He videoed his sermons while in England, sharing his experiences with his congregation in real time while keeping his family intact. He walked Wesley's Path and shared the sights and his reflections with them each week.

The Clay UMC sponsored the 2015 Pastor's Vision Tour to Burkina Faso, Africa, supporting the "Water is LIFE" with grants from the Hull, Bishop Raines and Bishop Alton Missions funds. This project not only serves to provide clean water in that country, it introduces young clergy to the mission field.

# Generous Heart

Elizabeth Marshall, better known as Libby, and her sister Jane were born into a generous family and they exemplified that wonderful spirit. Libby was the elder of the two sisters. To Deborah Calhoun, they seemed inseparable with Janie, Deborah's step-mother, as the muscle while Libby was the heart.

The girls grew up as preacher's kids. Both their mother and father, Zoa and George Snider, were pastors, which now seems normal, but in the early part of the last century this was quite extraordinary. Their father, Rev. George Snider, was appointed to the Methodist Church of Bourbon in 1943, which began the family connection to the town that would later be called home for all.

Libby made Bourbon her permanent home when she married Jonathan Marshall in 1950. Libby was a nurse and served in several positons in the medical field.

Jane was a teacher and lived in Plainfield much of her life.
On a visit back to

Bourbon she met her future husband and moved back to Bourbon when she married Harold Swihart in 1976.

After their parents retired, the Methodist Church of Bourbon became home for all. Libby played the organ, and her dad, George, sang in the choir. Their mother had slowed her work in the church because of her health.

Both sisters were extremely proud of their parent's ministry. Zoa (French) Snider was one of the first women ordained by the Methodist church. Their father had a gift of stewardship. It was said that when their father left a church it was more solid financially than when he came. That was something the girls took pride in and modeled his love and faith in the church.

In recognition and honor of the many dedicated years her parents served in the ministry, Elizabeth Marshall made a substantial gift to the Minister's Aid fund from her estate. This fund supports the needs of retired or disabled pastors and their families. The Snider family continues to give in loving support of The United Methodist Church.

## **Investing in Perpetuity**

God creates each of us in a unique way with individual gifts and interests. Creating a legacy that honors God's blessings in our lives and touches those people and ministries we love can be a lasting story for others to share. An endowment is a vehicle that can be used to create that legacy.

A permanent endowment is a fund in which the initial gift is invested in perpetuity and the earnings from the investment are used to support ministry. The donor selects the ministry and it can range from a specific church to a broad ministry area such as evangelism. Libby Marshall chose to honor her parents by providing



support for retired clergy and their families through the Minister's Aid Fund. Herschel and Guinevere Lesh created an endowment that supports two different ministries within the Conference as well their local church.

The "Uniform Prudent Management of Institutional Funds Act" (UPMIFA) outlines what are considered to be the best practices for management of endowments and other long term investments. There are several provisions, but a couple of the most significant areas addressed are investment of funds and dispersal of funds.

A couple of assumptions were made in developing these ideas, the first being that endowments are to be held for a long period. The investing process required for long term growth and stability with the production of income are very different from day traders or short term investors.

Another assumption is that funds need to be regularly disbursed from the funds. Unlike your pension funds, where you invest now for steady withdraws in the future, an endowment needs to maintain a consistent stream of disbursements now but also maintain the purchasing power of those disbursements.

UPMIFA is Indiana law and has set a standard of care for our endowed funds which all should consider in managing their foundations and endowments. The United Methodist Foundation of Indiana has implemented UPMIFA which allows us to distribute roughly 1/2 million dollars every year.
